## Fiscal Year: October 2021 - September 30, 2022

- 11,400 individuals served
- 7053 families served
- 699 volunteers contributed 3,942 hours of volunteer service
- 1,845 volunteer hours contributed by individuals living in poverty

# **Family Center Services**

718 families received income tax preparation services, collecting refunds totaling \$987,784.

\$5,907 in support services from our Ready to Work Program helped customers gain/maintain employment.

65,636 meals were provided through the Food Pantry.

Customers and Landlords were assisted with \$75,391 with rent and utility payments.

50 Community members attended a training on the impediments to Fair Housing.

3723 lunches were served through the Summer Food Service Program.

117 children provided with winter outerwear.

2,572 children received gifts at Christmas.

# Jefferson-Lewis Childcare Project (JLCP)



Community businesses have joined us to offer special recognition in the way of discounts or other promotions to Early Childhood Professional cardholders working in a Registered or Licensed program. The business also receives a window cling identifying them as a supporter of Early Childhood.



428 parents/caregivers able to gain or maintain employment or education through referrals made to licensed care

320 safe and affordable child care placement opportunities created with assistance from JLCP

845 children received adequate nutrition through meals provided by registered/licensed providers participating in the Child and Adult Care Food Program (CACFP)

\$523,525 reimbursed to child care providers through CACFP Child Care Homes sponsorship

452 childcare providers participated in training offered by Provider Services staff in 2022





# Housing & Energy Services

93 applicants were qualified for Weatherization or Empower services

78 home energy audits performed

33 homes provided with EMPOWER improvements, leading to reduced energy usage and costs

72 homes provided with weatherization improvements, leading to reduced energy usage and costs

#### Did you know?

Every \$1 invested in Weatherization Assistance returns \$4 in energy, health and safety benefits.

Weatherization saves under-resourced families with an average of \$283 (30%) per year in heating, cooling and electric costs







# Head Start

### Medical and Dental Care

- 305 children obtained age appropriate immunization, medical and/or dental care.
- 239 newly enrolled children (1st year student) received developmental and sensory screening
- 25 children were diagnosed as needing medical treatment/follow-up.
- **3**3 children received medical follow-up.
- 292 newly enrolled children received a professional dental exam.
- 66 children were diagnosed as needing dental treatment.
- 47 of those children received dental treatment.
- We served 60 children with diagnosed disabilities.



# Key Accomplishments 2021-2022

- Continued to have 3 certified CLASS (Classroom Assessment and Scoring System) observers on staff.
- 64% of our Master Teachers have at least a Bachelor's Degree in Early Childhood Education. 21% of those have a Master's Degree, and 36% have an Associate Degree in Early Childhood Education or related field.
- 40% of the Teacher Assistants have at least an Associate Degree and 60% have a CDA (Child Development Associate Certificate)
- 1 Teacher Aides completed the CDA Program.
- Our centers were all enrolled in the Quality Stars New York Program.
- Continued work with the North Country Alliance for Early Childhood Education Birth 3rd grade to include involvement from several school districts, daycares, and community stakeholders.
- 3 staff received their Family Development Credentials.

## **Community Assessment Findings**

- Substance abuse and addiction rising in the community.
- Lack of summer recreation sites available for children in the summer.
- COVID restrictions have caused the mental health needs to rise nationwide but access and patients seeking services has not changed.
- Limited access to transportation.
- Enhanced unemployment has made it very difficult to recruit employees, especially in the service industry, child care business and other places that pay minimum wage.
- Limited affordable, quality child care spaces.

# **Pre-K Collaboration**

Community Action operates Pre-K Programs in collaboration with 3 local school districts to provide educational services and family support to a total of 329 students and their families.

## Watertown City School District

– 71 full-day slots at Ohio, Sherman, and North Elementary Schools, blended funding for
36 full-day slots for 4 yr. olds and 17 full-day slots for 3 yr. olds located at Watertown
Head Start

## Indian River School District

– 198 part-day slots located at Philly, Evans Mills, and Calcium Primary Schools. *Sackets Harbor School District* - 18 full-day slots.

## Pre-K Key Accomplishments

- 50% of the teachers have a Master's Degree and are NYS Certified B-2.
- 50% of teachers have a Bachelors's Degree with a 5-yr. plan.
- 1 Certified CLASS observer.
- 1 staff earned their Master's Degree and 1 staff member completed their CDA.
- All staff were trained on trauma informed care and anti bias.

## 2022 Revenues & Expenditures

Community Action Planning Council is subject to a comprehensive financial audit each year. The most recent audit (October 1, 2021 – September 30, 2022) was reviewed and approved by the board of directors on March 16, 2023. An independent auditing firm found the agency to be in compliance within all program areas and reported no weaknesses or deficiencies with fiscal practices or internal controls.


